



UNLIMITED SYNCHRONIZATION AGREEMENT - UNLIMITED USE

This UNLIMITED SYNCHRONIZATION AGREEMENT is for synchronization rights and only for your motion picture, home video, YouTube, TV show, major production company or independent film, video games or web series. This License is not for recording artist, songs, mix-tapes, iTunes, albums or sound recording. This is strictly for video/film.

Synchronization Rights. The Licensor (producer/ TheDopeSociety.com/Giuseppe D'angelo Liuzzo) hereby grants to Licensee (buyer) an UNLIMITED License to copy, perform, edit and/or loop portions of, record on film, video, digital animations, and video games (collectively, "Projects") and use the Master Recording in synchronization or timed relation with the production of UNLIMITED Projects.

This synchronization agreement, made and entered into on the **DATE-OF-ORDER** serves as a legally binding contract between **THE-PRODUCER(S)** ("Licensor") and **THE-BUYER** ("Licensee"). This synchronization agreement grants the Licensee UNLIMITED rights to the instrumentals **BEATS-PURCHASED** ("Instrumental").

Master Recording

The Licensor (producer/TheDopeSociety.com/Giuseppe D'angelo Liuzzo) hereby grants the Licensee (buyer) the right to record vocal and/or instrumental synchronization to any or all parts of

the Instrumental. The Licensee (buyer) understands that their usage of the Instrumental is UNLIMITED to the Licensee (buyer) or production company. This UNLIMITED License allows the Licensee (buyer) usage of instrumental in any or all of the Licensee's (buyer) new videos and films. The Licensee (buyer) may edit the Instrumental that is being licensed in this UNLIMITED agreement, by changing the arrangement of the Instrumental or by removing any melodies, instruments, drum programming or sounds that are contained within the Instrumental to fit the Licensee's (buyer) needs.

Ownership

The Licensor (producer) maintains 100% full rights (copyright, publishing and ownership) of the instrumental, and can continue to sell it non-exclusively and/or exclusively. The Licensee has neither the right nor authority to sell or license the rights to the Instrumental whether in whole or part to any other party. In the event another individual purchases exclusive rights to your licensed Instrumental you will retain your UNLIMITED rights under the limitations listed in this agreement and until these terms have been fulfilled.

Credit

The Licensee (buyer) must give production credit to the Licensor (producer/TheDopeSociety.com/Giuseppe D'angelo Liuzzo) for any and all distributed material. This can be done verbally (through recorded vocals on the Master Recording) or written in the credits, flyers, billboards, booklets, covers. The Licensor (producer/TheDopeSociety.com/Giuseppe D'angelo Liuzzo)

reserves the right to keep an audio signature at the beginning of all instrumentals.

Synchronization Rights are also included with Exclusive License Agreement. This Synchronization Agreement License will never expire. This Synchronization Agreement is royalty-free and allows use in multiple projects with unlimited distribution.

- use instrumental itself as background music to motion picture, home video, YouTube, TV show, major production company or independent film, video games or web series.
- add vocals, noises or instruments to the instrumental for use as background music.
- covers commercial rights for content sharing sites such as YouTube and Vimeo.
- edit or rearrange the instrumental so that it will suit your project. [Unlimited License type]
- use of instrumental or recorded song in video games.
- use of the instrumental or song on a website.
- use of the instrumental or song in a software or application.
- receive the untagged, high quality WAV file and Multi-tracks [Unlimited License type].
- permission to use recorded song for soundtracks, radio play, shows and concerts.
- usage of the instrumental is entirely royalty-free for the designated distribution-limit.

Synchronization rights have been included with Exclusive Rights Agreement. Simply purchase one of these licenses that suits your project's distribution goal and you automatically have synchronization rights.
